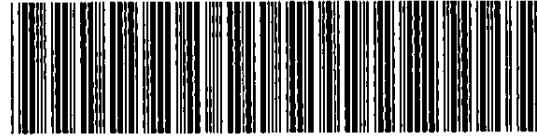



1. The current name of the corporation is WOTITZKY, WOTITZKY, ROSS & TUTTLE, P.A. (the "Corporation").


