ARTICLES OF INCORPORATION
OF
DeBERN SERVICE CORPORATION

ARTICLE I - NAME

The name of this corporation shall be DeBERN SERVICE CORPORATION, and the address of the principal office of the corporation is 216 Carlton Avenue, DeLand, Florida 32720.

ARTICLE II - DURATION

The term of existence of this corporation shall be perpetual.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of conducting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of common stock, each share with a par value of \$1.00.

ARTICLE VII - INCORPORATOR

The name and address of the incorporator of this corporation is DONNA J. DEMPSEY, 216 Carlton Avenue, DeLand, Florida 32720.


ARTICLE VIII - BY-LAWS
