ARTICLES OF INCORPORATION OF J.P.B. FINANCIAL CONSULTING, INC



The undersigned incorporator, for the purpose of forming a Corporation under the Floridal Business Corporation Act, hereby adopts the following Articles of Incorporation

1. NAME.

The name of the Corporation is J.P.B. FINANCIAL CONSULTING, INC. (the "Corporation")

2. PRINCIPAL OFFICE.
