The undersigned incorporator, for the purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation

1. NAME.

The name of the Corporation is J.P.B. FINANCIAL CONSULTING, INC. (the "Corporation")

2. PRINCIPAL OFFICE.

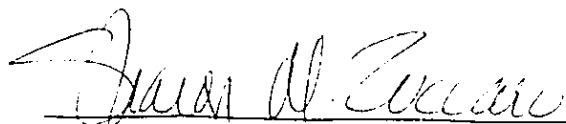

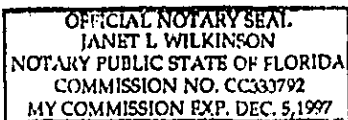
