The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: HOME MADE LUNCH & DINNER AT COURTSIDE CAFE, INC.

The principal place of business of this corporation shall be 357 Racquet Club Road, Fort Lauderdale, Florida 33326.

ARTICLE II - NATURE OF BUSINESS

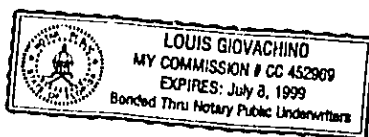
