

ARTICLES OF INCORPORATION  
OF

***MEDIAWAVE, INC.***

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of the Corporation is ***MEDIAWAVE, INC.***

**ARTICLE II - DURATION**

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.

**ARTICLE III - PURPOSE**

The Corporation may engage in any activities or business permitted under the laws of the United States and the State of Florida.

**ARTICLE IV - CAPITAL STOCK**

The total number of shares of capital stock authorized to be issued by the Corporation will be Ten Thousand (10,000) shares having a par value of One Dollar (\$1.00) per share. Each of the said shares of stock will entitle the holder thereof to one (1) vote at any meeting of the stockholders.

**ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT**

The Board of Directors may, from time to time, move the principal office to any other address.




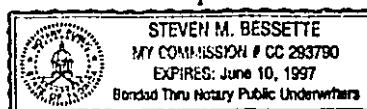
