# ARTICLES OF INCORPORATION

OF

## REN TRURO CORP.

The undersigned does hereby subscribe to, acknowledge and the the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

## ARTICLE ONE

The name of the corporation is: REN TRURO CORP. The principal address of the corporation is: 330 Clematis Street, Suite #218, W. Palm Beach, Florida 33401.

## ARTICLE TWO

This corporation shall commence its existence upon filing and shall exist perpetually thereafter unless sooner dissolved according to law.

# ARTICLE THREE
