ARTICLE I

NAME

The name of this Corporation is LITTLE TOKYO OF SUPERMALL, INC. The address of the Corporation is 14497 N. Dale Mabry Highway, Suite 201, Tampa, Florida 33618.

ARTICLE II

DURATION

This Corporation shall have perpetual existence.

ARTICLE III
