THE UNDERSIGNED, has executed the following document $\sqrt[3]{4}$ incorporator of the above named corporation, a corporation organized under the laws of the State of Florida, and all rights, duties and obligations of the undersigned as incorporator, are to be determined in accordance with the laws of the State of Florida.

ARTICLE ONE - NAME AND PRINCIPAL OFFICE LOCATION

The name of this corporation shall be: THLINE MANUFACTURING, INC. The principal office address is 1900 N.W. 33rd Street, Pompano Beach, Florida 33064.

ARTICLE TWO - DURATION

This corporation shall commence existence upon the filing of these Articles of Incorporation by the Department of State, State of Florida, and shall have perpetual existence.
