

OF

WORKAHOLICS BENEFITS, INCORPORATED EFFECTIVE DATE

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation shall be Workaholics Benefits, Incorporated and the principal place of business of this corporation shall be 1611 14th Street West, Bradenton, Florida 34205 and the mailing address of the corporation shall be 1611 14th Street West, Bradenton, Florida 34205.

ARTICLE II: NATURE OF BUSINESS



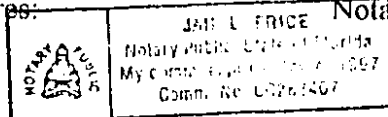


