FILED ARTICLES OF INCORPORATION

WORLDWIDE INTERNET, INCHALLAHASSEE.FLORIDA

The undersigned incorporator, being a natural person competent to contract, hereby adopts these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of this Corporation is WORLDWIDE INTERNET, INC.

ARTICLE II

This Corporation shall commence upon the execution of these Articles and shall exist perpetually.

ARTICLE III

The purpose of this Corporation is to provide computer and internet services and engage in any business lawful under the laws of the State of Florida or the United States.
