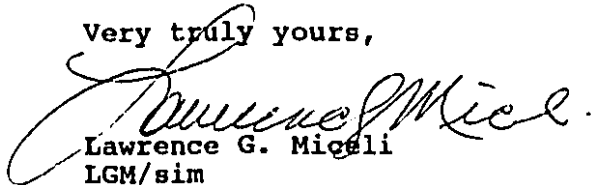

### ARTICLE I

#### CORPORATE NAME

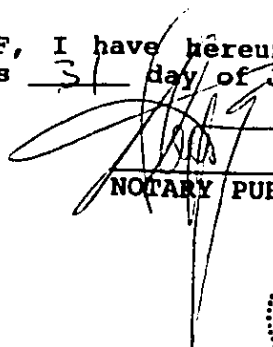
