### ARTICLES OF INCORPORATION

# ANNA INDUSTRIES II, INC.

The undersigned incorporator for purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

The name of the Corporation is ANNA INDUSTRIES II, INC. (the "Corporation").

SECOND: The street address of the initial principal office and mailing address of the Corporation is 6825 Sunset Drive, Second Floor, Miami, Florida 33143.

THIRD: The Corporation is authorized to issue 1,000 shares of common stock, par value \$1.00 per share.

FOURTH: The street address of the initial registered office of the Corporation is: 2601 South Bayshore Drive, Suite 1600, Miami, Florida 33133 and the registered agent at that address is: A Z Registered Agent Corporation.
