**ARTICLES OF INCORPORATION  
OF  
UNDER HER MANTLE MINISTRIES, INC.  
A FLORIDA CORPORATION**

**ARTICLE I**

**NAME AND ADDRESS**

The name of this corporation is Under Her Mantle Ministries Inc., and its principal place of business shall be at 6231 Marlberry Dr., Orlando, FL 32819, but it may have and maintain other such places within the United States and elsewhere as its Board of Directors may, from time to time, determine necessary.

**ARTICLE II**

**DURATION**

The period of the duration of this corporation is perpetual.

**ARTICLE III**

**CORPORATE PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

**ARTICLE IV**

**CAPITAL STOCK**

This corporation is authorized to issue 1000 shares of common stock.
