ARTICLE ONE - NAME

THE NAME OF THIS CORPORATION SHALL BE ADVANTAGE MARINE SERVICES, INC.

ARTICLE TWO - DURATION

THIS CORPORATION SHALL EXIST PERPETUALLY.

ARTICLE THREE - PURPOSE

THIS CORPORATION MAY ENGAGE IN ANY ACTIVITY OR BUSINESS PERMITTED UNDER THE LAWS OF THE UNITED STATES OF AMERICA AND THE STATE OF FLORIDA, EXCEPT THAT IT SHALL NOT CONDUCT BUSINESS AS A BANKING, SAFE DEPOSIT, TRUST, INSURANCE, CANAL, RAILROAD, TELEPHONE, TELEGRAPH, CEMETERY COMPANY, BUILDING AND LOAN ASSOCIATION, MUTUAL FIRE INSURANCE COMPANY, COOPERATIVE ASSOCIATION, FRATERNAL SOCIETY, STATE FAIR OR EXPOSITION.

ARTICLE FOUR - CAPITAL STOCK

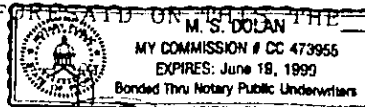
