ARTICLE ONE - NAME

THE NAME OF THIS CORPORATION SHALL BE JEAN REHA, INC.

ARTICLE TWO - DURATION

THIS CORPORATION SHALL EXIST PERPETUALLY.

ARTICLE THREE - PURPOSE
