ARTICLE I
CORPORATE NAME

The name of this Corporation is Page Pro, Inc

ARTICLE II
DURATION

This Corporation shall be perpetual existence commencing on the date of the filing of the Articles of Incorporation by the Department of State

ARTICLE III
PURPOSE

CORPORATE POWERS


This Corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act




