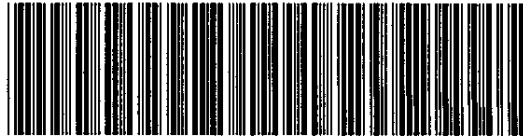

3. The text of the amendment adopted, which amends and replaces Article I, is the following:


ARTICLE I - NAME
