**ARTICLE 1 - CORPORATE NAME**

The name of the corporation shall be

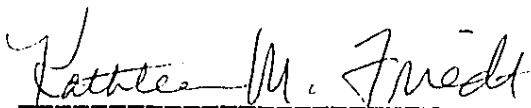
