The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I  
NAME

The name of the corporation is INDEPENDENTS CAB CO., INC. with its mailing address and principal office at 567 Squire Lane, Kissimmee, Florida 34746.

ARTICLE II  
DURATION

The term of existence of this corporation is perpetual beginning the date of filing.

ARTICLE III  
PURPOSE

The purpose for which the corporation is organized is the operation of a taxi cab company to transport people and packages by vehicle, and any other lawful enterprise for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV
