## ARTICLES OF INCORPORATION

OF

APPLE AUTO INSURANCE OF TAMPA BAY, INC.

The undersigned Incorporator heroby forms a corporation under Chapter 607 of the laws of the State of Florida.

### ARTICLE I. NAME

The name of the corporation shall be:

APPLE AUTO INSURANCE OF TAMPA BAY, INC.

## ARTICLE II. NATURE OF BUSINESS
