ARTICLES OF INCORPORATION

ARTICLE I

NAME

THE NAME OF THIS CORPORATION IS TWO WAYS INTERNATIONAL SERVICE, CORP. and the mailing address is 1945 S.W. 86 Ave. Mlami, FL 33155.

ARTICLE II

DURATION

This corporation shall have a perpetual existence, unless dissolved according to law.
