

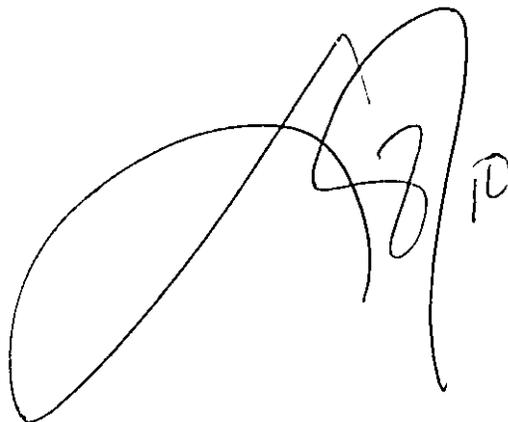

The undersigned incorporator for purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST:** The name of the Corporation is Isaac Sales Corp. (the "Corporation").

- THIRD:** The Corporation is authorized to issue 500 shares of common stock, par value \$.01 per share.
