To whom it may concern,

I incorporated in the state of Florida August 10, 1995. At that time the incorporation was being handled by my accountant who was also my registered agent. There was some confusion due to the assignment of two FEI numbers. I authorized payment of the bill for the incorporation and it was sent in for number 65-0644783.

I was unaware that these documents were due each year and did not discover so until I learned that my incorporation had been "dissolved". This only came to my attention when I went to apply for a license to sell tobacco in my shop. When looking up our information in public records the clerk advised me that it had been dissolved in 1997. At that time I called my accountants office and they asked if I had received the yearly renewal or any notices reference the dissolution. I replied that I had not. I followed up by requesting the reinstatement forms via phone and when these never arrived I downloaded it from the Internet.

We have completed the reinstatement forms, but I am writing this letter to respectfully request that you please consider abating all or part of the \$900.00 penalty. I did not intentionally neglect to file, I was just unaware of the yearly renewal, I consequently did not know I should have questioned the whereabouts of my Annual Report.
