I am in receipt of your letter dated 12/12/97. I am also enclosing a check in the amount of \$165.00 and the document you sent to me.

I purchased this corporation in April (1997) and was under the impression that all papers were in proper order, including the renewal of the corporation. I never received the packet that is normally sent out when renewal is due. I am now aware of a problem we have with the mail. When it arrives, it is left at the front of the hall in a designated area.
