The undersigned, a natural person, competent to contract, hereby subscribes these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

ARTICLE I

NAME: *The name of the corporation is: CECILIAN INC.*

ARTICLE II

NATURE OF BUSINESS: *This corporation may engage in any activity or business permitted under the laws of the State of Florida and of the State of Florida.*

ARTICLE III
