Articles of Incorporation of Sharp Cab Company

ARTICLE

Name and Duration

ALWEST STATES The name of the Corporation is Sharp Cab Company. The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

ARTICLE II

Principle Office

The address of the principal office of the Corporation in the State of Florida is 624 Lancaster Road, in the City of Orlando.

ARTICLE III

Registered Office and Agent
