The undersigned, acting as incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is A SIGN-IT OF SOUTHWEST FLORIDA, INC., and the mailing address is 8798 Commerce Drive, Bonita Springs, Florida 33923.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.

ARTICLE IV

The corporation shall have authority to issue two hundred (200) shares, all of one class, One (\$1.00) Dollar par value.

ARTICLE V

ARTICLE VII

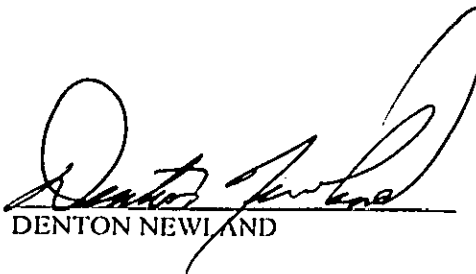

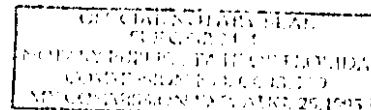
