ARTICLES OF INCORPORATION



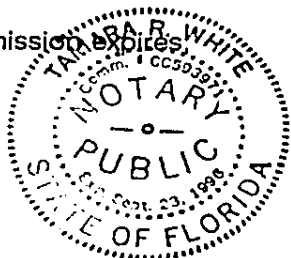
