KNOW ALL PERSONS BY THESE PRESENTS, that the undersigned, natural person of the age of twenty-one years or more, acting as incorporator of a corporation under the provisions of the statutes of the State of Florida, adopts the following Articles of Incorporation.

**ARTICLE I
CORPORATE NAME**

**ARTICLE II
DURATION**

The period of duration of the corporation is perpetual.

**ARTICLE III
PURPOSES AND POWERS**

Section 1. Purposes.

The purposes for which this corporation is formed are:

- a. to conduct any and all lawful business.

Section 2. Powers.

Subject to any specific limitations imposed by these Articles of Incorporation, the corporation shall have the following powers:

- a. All those powers authorized by statute.
- b. The power to carry out the purposes set forth above in any state, territory, district or possession of the United States, or in any foreign country, to the extent that such purposes are not forbidden by the law of such state, territory, district or possession of the United States, or by such foreign country.

- c. The power to indemnify any director, officer or employee, or former director, officer or employee of the corporation against expenses actually and necessarily incurred by him or her in connection with the defense of settlement of any action, suit or proceeding in which he or she is made party by reason of being or having been such director, officer or employee, except in relation to matters as to which he or she shall be adjudged of misconduct in the performance of duty.

ARTICLE IV AUTHORIZED SHARES

The aggregate number of shares which the corporation shall have authority to issue is **ONE HUNDRED (100) SHARES COMMON STOCK**, all of which shares shall be with a par value of **ONE CENT (\$0.01)**.
