ARTICLES OF INCORPORATION  
OF

The undersigned subscribes to these Articles of Incorporation, natural person, competent to contract, and hereby form a corporation for profit under the laws of the state of Florida. Corporate existence shall begin upon acceptance of these Articles. This corporation is to be a Small Business Corporation as defined in Section 1244 subdivision (c)(2) of the Internal Revenue Code.

ARTICLE I. Name. The name of the corporation is
