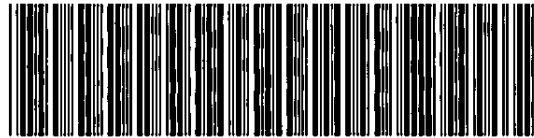

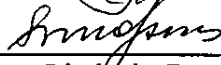
ARTICLE VI
