The undersigned, all of whom are duly licensed to practice Law in the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida Statutes and Florida Professional Service Corporation Act, adopt the following Articles of Incorporation:

I.NAME

The name of the corporation shall be Mosley, Savage & Essien, P.A.




