ARTICLES OF INCORPORATION OF

SECRETARY OF STATE

OKINAWAN KARATE SHUBUKAN, INC.

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the Corporation is OKINAWAN KARATE SHUBUKAN, INC., (hereinafter, "Corporation"). The English translation for the name of this corporation is "Okinawan Karate House of Learning".

ARTICLE 7 - CORPORATE CAPITALIZATION

- 7.1 The maximum number of shares that this Corporation is authorized to have outstanding at any time is SEVEN THOUSAND FIVE HUNDRED (7,500) shares of common stock, each share having the par value of ONE DOLLAR (\$1.00).

ARTICLE 8 - POWERS OF CORPORATION
