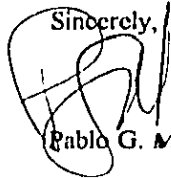

**ARTICLES OF INCORPORATION  
OF

The undersigned, being individuals, do hereby act as incorporators in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "corporation") is Pablo G. Martinez, P.A.

SECOND: The mailing address, wherever located, of the corporation, if known, is 5655 Johnson St., Suite A, Hollywood, FL 33021.

THIRD: The address, wherever located, of the principal place of business of the corporation, if known, is 5655 Johnson St., Suite A, Hollywood, FL 33021.

FOURTH: The number of shares that the corporation is authorized to issue is TWENTY (20), all at ONE DOLLAR (\$1.00) par value and are of the same class and are to be Common shares.

FIFTH: The street address of the initial registered office of the corporation in the State of Florida is 6371 Rodman St., Hollywood, FL 33021.

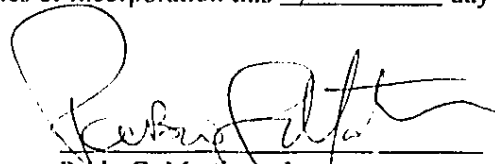
EIGHTH: The duration of the corporation shall be perpetual.
