

The undersigned acting as Incorporator of a corporation under the Florida Business Corporations Act, adopts the following Articles of Incorporation for such corporation.

1. Name The name of the corporation is The American-Kuban Business Center Corporation.
2. Principal Office/Mailing Address The principal office of the corporation is 1276 Flying Bridge Lane, Osprey, Florida 34229 The mailing address is the same.
3. Shares The number of shares the corporation is authorized to issue is one thousand (1,000) shares.
4. Preemptive Rights. Each shareholder of this corporation shall have the first right to purchase shares of any class, kind or series of stock in this corporation that may from time to time be issued, including shares from the treasury of this corporation, in the ratio that the number of shares he holds at the time of issue bears to the total number of shares by any shareholder who does not exercise it and pay for the shares preempted within thirty days of receipt of a notice in writing from the corporation, stating the prices, terms and conditions of the issue of shares, and inviting him to exercise his preemptive rights. 
