The name of this corporation is CDDR, INC.

ARTICLE II -- DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III -- PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended.

To Department of State State of Florida

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the corporation hereinafter named (the "corporation") does hereby adopt the following Articles of Amendment.

- 1. The name of the corporation is CDDR, Inc.
- 2. Article IV of the Articles of Incorporation of the corporation is hereby amended so as henceforth to read as follows:

ARTICLE IV -- CAPITAL STOCK

This corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares."

- 3. Article IX of the Articles of Incorporation of the corporation is deleted.
- 4. The change in Article IV shall be implemented by eliminating 900 shares of the authorized but unissued shares of common stock. There shall be no change in the 100 shares of issued and outstanding common stock.
- 5. The date of adoption of the aforesaid amendment was November 8, 1995.
- 6. The number of votes cast for the said amendments by the shareholders was sufficient for the approval thereof.
