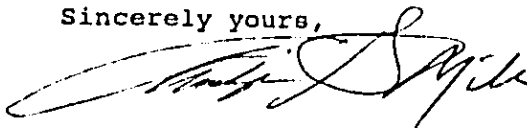

ARTICLE I - Name

The name of this Corporation is:

RYAMAR, INC.

ARTICLE II - Duration

This Corporation shall have perpetual existence.

ARTICLE III - Purposes and Powers

This Corporation is organized for the purpose of and shall have the authority to transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, (1989) as presently enacted and as it may be amended from time to time.

ARTICLE IV - Capital Stock

This Corporation is authorized to issue 1,100 shares of One Dollar (\$1.00) par value common stock, which shall be designated as "Common Shares".

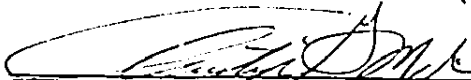
