I, the undersigned, for the purpose of beginning a corporation for profit under the laws of the state of Florida, adopt the following Articles of Incorporation.

ARTICLE ONE. NAME

The name of this corporation is B & J DELIVERY, INC..

ARTICLE TWO. PRINCIPAL OFFICE

The address of the principal office of the corporation is 1304 N.E. 32nd Avenue, Gainesville, Florida, and it's mailing address is 1304 N.E. 32nd Avenue, Gainesville, Florida 32609.

ARTICLE THREE. DURATION

This corporation shall exist perpetually commencing upon the date of filing of these Articles of Incorporation with the Department of State.

ARTICLE FOUR. PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE FIVE. CAPITAL STOCK

This corporation is authorized to issue three hundred (300) shares of no par common stock.

ARTICLE SIX. PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he or she already holds, shall have the right to purchase his or her prorata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others, and such preemptive right shall also be in favor of shareholders who received their issued stock within six (6) months from the effective date of incorporation, irrespective of whether the stock was sold for cash, for other tangible or intangible property, or for services already performed.

ARTICLE SEVEN. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 1304 N.E. 32nd Avenue, Gainesville, Florida 32609, and the name of the initial registered agent of this corporation at that address is Robert W. Hodgson.

ARTICLE EIGHT. MANAGEMENT BY SHAREHOLDERS

All corporate powers shall be exercised by or under the authority of, and the business and affairs of this corporation shall be managed under the direction of, the shareholders of this corporation.

ARTICLE NINE. INCORPORATOR

ARTICLE TEN. BYLAWS

The power to adopt, alter, amend or repeal bylaws shall

ARTICLE TWELVE. AMENDMENT

This corporation reserves to its shareholders the right

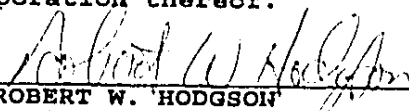

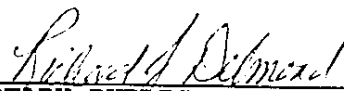
