The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

# ARTICLE 1. - NAME AND ADDRESS

# ARTICLE 2. - DURATION OF CORPORATION EXISTENCE
