ARTICLES OF INCORPORATION
OF
INSTANT HOME PROTECTION, INC.

I, ALBERT R. CARTIER, do hereby incorporate myself for the purpose of becoming a corporation for profit under Florida law.

ARTICLE I

The name of the corporation is: INSTANT HOME PROTECTION, INC..

ARTICLE II

This corporation may engage in the retail sale and installation of home security equipment and related products. The corporation may also conduct other related enterprises not prohibited by law.
