The undersigned, being a natural person sui juris and a subscriber to the shares of the Corporation to be organized hereunder, for the purpose of forming a corporation under Fla. Stat. Ch. 621, does hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of the Corporation is REEVES & COMPANY, P.A.

ARTICLE II - DURATION

The term of existence of the Corporation is perpetual.

ARTICLE III - PURPOSE

The nature of the business and the objects and purposes for which the Corporation is organized is to practice public accounting and to engage in such activities as are permitted by the Professional Service Corporation Act, Chapter 621 of the Florida Statutes.

ARTICLE IV - PRINCIPAL OFFICE

The street address and mailing address of the initial registered office and the principal office of the corporation shall be 208 Stuart Avenue East, Lake Wales, FL 33853, and the name of the initial registered agent at that address shall be DWIGHT L. REEVES.

ARTICLE V - CAPITAL STOCK

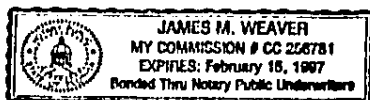


