THE UNDERSIGNED INCORPORATOR, for the purpose of forming a corporation under the laws of the State of Florida, Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. CORPORATE NAME

The name of this Corporation shall be **FRASER INTERNATIONAL SERVICES, INC.**

ARTICLE II. PRINCIPAL OFFICE

The principal office of the Corporation shall be 100 So. Biscayne Boulevard, Ste. 700, Miami, FL 33131. The Board of Directors from time to time may move the principal office to any other address in the State of Florida.

ARTICLE III. NATURE OF BUSINESS AND POWERS

The general purpose of this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

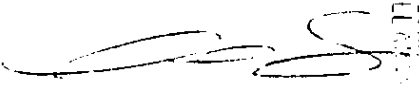
