OF

ARTICLE I: CORPORATE NAME

The name of this corporation is: RICK'S FLEET MAINTENANCE, INC.

ARTICLE II: PRINCIPAL OFFICE

The principal office of this corporation shall be:

ARTICLE III: NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under law.

ARTICLE IV: CAPITAL STOCK

The maximum number of shares that this corporation is authorized to issue and have outstanding at any one time is ONE THOUSAND (1,000) shares of common stock having a par value of \$1.00 per share.

ARTICLE V: TERM OF EXISTENCE

This corporation shall have perpetual existence commencing upon filing of these Articles of Incorporation.

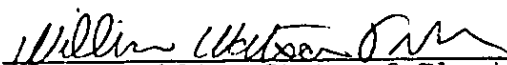
