ARTICLE I - NAME

The name of this corporation is LEGENDS VINTAGE MOTORCYCLES, INC.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III - DURATION

This corporation shall have perpetual existence, commencing upon the 10th day of August, 1995, being the same date as the subscription to and acknowledgment of these Articles of Incorporation.

ARTICLE IV - PURPOSE

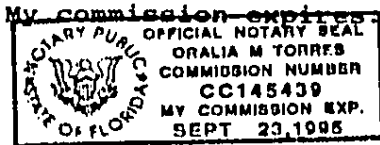
