The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is: DESIGN ADVISORY, INC.

ARTICLE II - PRINCIPAL OFFICE

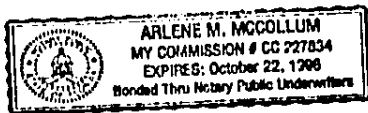
