ARTICLES OF INCORPORATION OF

ARTICLE I - NAME

The name of this corporation is MER-ANI DME SERVICES, INC.

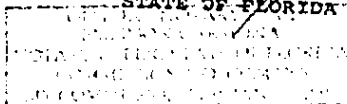
