**ARTICLE ONE
NAME**

PURPOSE**

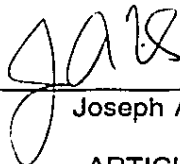
The Corporation may transact any and all lawful business for which corporations may be incorporated in Florida.

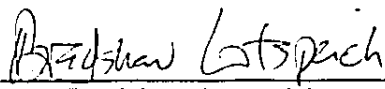
