ARTICLE I
NAME

The name of this corporation shall be: THE EIGHTIES BROADCASTING CORPORATION.

The name and address of the person signing these Articles as Incorporator is Russell A. Oasis.

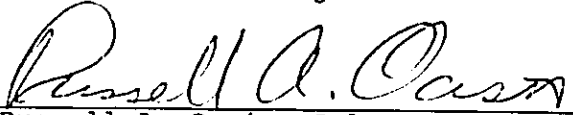
ARTICLE X
