## ARTICLES OF INCORPORATION OF

### SANDY MAR, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

#### ARTICLE ONE

##### NAME

The name of the corporation is SANDY MAR, INC.

#### ARTICLE TWO

##### CORPORATE DURATION

The duration of the corporation is perpetual.

#### ARTICLE THREE

##### PURPOSE OR PURPOSES

1. To engage in the business of operating a sign company.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade of business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.

#### ARTICLE FOUR

##### CAPITALIZATION

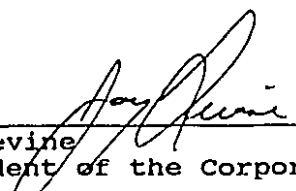

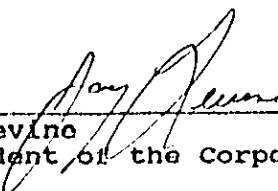
